GRANT OF SHARE OPTIONS

The Board of Directors (the “Board”) of the Company announces that on 7 November 2017, the Company granted 7,250,000 share options to certain individuals under the Company’s share option scheme adopted on 10 December 2009, subject to acceptance of the individuals (the “Grantees”).
